The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the changes below:

Revise the First Aid Statement in accordance with PR Notice 2001-1

### **Deficiencies**

1. Revise Precautionary statement as follows:

"Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling. Harmful if inhaled. Avoid breathing vapor. Remove contaminated clothing and wash before reuse."

Liquid Winterizer 7 works best when added to a freshly cleaned pool, Liquid Winterizer 7 should be used at the rate of one quart for every 10,000 gallons of

Empty skimmer of all chemicals and/or debris. Remove any chemicals that may be in an in-line automatic chemical dispensing device. Make sure that filter is on and that water is properly recrulating through stimmer, Pour Liquid Winterier 7 slowly into stimmer, making sure that the figuid is drawn into the system at the same rate. Keep filter on for 2-3 hours to assure good distribution.

If equipment has been shut down for the season, fill clean pail with at least 4 gallons of fresh water and stir in no more than 1 gallon of Liquid Winterizer 7. Pour resulting dilution into pool while walking around the perimeter. Repeat until

containers should be placed in a plastic bag and discarded in trash. Mop up spills with clean water. All pesticides should be kept out of reach of children and stored away from food.
