

This product is compatible with most commonly used swimming pool chemicals, but should not be mixed with soap and other cleaners or premixed with other water-treating chemicals. INITIAL DOSE: 2 gallons of this product to 50 000 calions of water.

MAINTENANCE DOSE: 2 quarts of this product to 50,000 gallons of water.

initial dose is used when filling pool beginning of swimming season. If pool has DISPOSAL: Do not reuse empty container, visible algae growth, treat with initial dose. Rinse thoroughly. Securely wrap in several Vacuum pool after 24 hours to remove algae layers of newspaper and discard in trash. debris.
