The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the **Busan 77 RED** and has concluded that your submission is acceptable.

NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please note that the record for this product currently contains the Confidential Statement of Formulation (CSF) listed below. Any previously dated CSFs are superseded.

A copy of your label stamped "Accepted" is enclosed along with copies of the acute toxicity and product chemistry reviews completed for the subject product. Products shipped after 12 months from the date of this amendment or the next printing of the label whichever occurs first, must bear the new revised label. 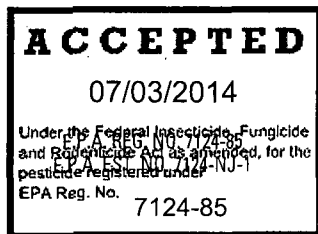

DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is used to control the growth of algae in spas. For maximum effectiveness spas containing heavy growth of algae must be cleaned prior to using this product.

Spas having just visible growth require an initial dose of 4-13 fluid ounces of this product per 500 gallons of water. For treatment of a freshly cleaned and filled spa, add initially 2-4 fluid ounces of this product per 500 gallons of water. Subsequent additions of 1-5 fluid ounces of this product per 500 gallons of water should be made every 5-7 days after initial treatment for maintenance.

WINTERIZING USE DIRECTIONS:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is used to control the growth of algae. For maximum effectiveness heavy growth of algae must be cleaned prior to using this product.

Visible growth requires an initial dose of 40-60 fluid ounces of this product per 5,000 gallons of water. For treatment of freshly cleaned water, add initially 20-40 fluid ounces of this product per 5,000 gallons of water.

This product is compatible with those chemicals normally used to treat spas and is effective at both acid and alkaline pH. This product can be used in spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Leaking or damaged containers must be placed in a plastic bag and discarded in trash. Mop up spills with clear water. All pesticides must be kept out of reach of children and stored away from food.

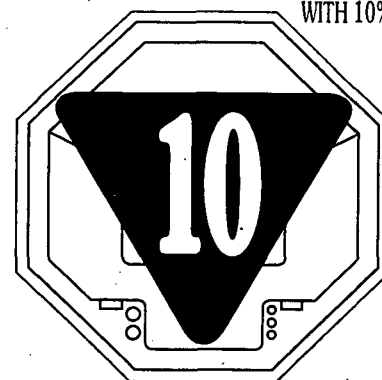
PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on the site or at an approved waste disposal facility.

CONTAINER HANDLING:

Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling, if available, or discard in trash.
