The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions below.

- Revision to First Aid Statement in accordance with PR Notice 2001-1

Conditions

1. Add the following to the Directions for Use statement: "Reentry into treated swimming pools is prohibited above levels of 4 ppm of chlorine."
2. The ingredient statement must be shown to total 100%.

A stamped copy of the labeling accepted with conditions is enclosed. Submit one (1) copy of your final printed label before distributing or selling the product bearing the revised labeling.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.

FIRST AID:

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

IF IN EYES: Hold eye open and rinse slowly with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, and decorative fountains. For maximum effectiveness pools, spas, whirlpools, hot tubs and decorative fountains containing heavy growth of algae should be cleaned prior to using this product.

For pools having just visible algae growth (**problem solving**) add an initial dose of 23.5 to 36.4 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning.

For freshly cleaned and filled pools add initially (**start up**) 12.8 to 23.5 fluid ounces of this product per 10,000 gallons of water.

Subsequent additions (**pool maintenance**) of 4.3 to 8.6 fluid ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains having just visible algae growth require an initial dose of 2 to 4 fluid ounces of this product per 1,000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, hot tub, or decorative fountain, add initially 1 to 2 fluid ounces of this product per 1,000 gallons of water. Subsequent additions of 0.5 to 0.8 fluid ounces of this product should be made every 5 to 7 days after initial treatment for maintenance.

This product is compatible with those chemicals normally used to treat pools, spas, and decorative fountains and is effective at both acid and alkaline pH. This product can be used in pools, spas, and decorative fountains treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Keep container closed when not in use. Leaking or damaged containers should be placed in a plastic bag and discarded in trash. Mop up spills with clean water. All pesticides should be kept out of reach of children and stored away from food.

DISPOSAL: Do not reuse empty container. Wrap container and place in trash. 4/C #2017
