DIRECTIONS

Wood Preservation: In treating new construction lumber, individual members should be soaked in Penta Preservative for at least 3 minutes perinch of thickness. All joints and ends of boards should receive particularly thorough treatment. Treated wood cannot be painted. Do not nail wallboard or other absorbent materials over treated wood until completely dry.

On existing structures Penta Preservative will control fungal rots and decay only. Wood not in contact with the ground such as frames, subfloors, sills, joists, etc., should be given 2 applications by swabbing or brushing.

Fence posts should be peeled, seasoned, and soaked for at least 24 hours and preferably 48 hours in a vertical position with butts down. The best treatment is full length coverage; if butt treatment is used, set with 12 inches of treated wood extending above ground level.

Ready To Use PENTA PRESERVATIVE

Sunnyside Penta Preservative can be applied to lumber, poles, posts and other wood products. When used according to directions, it gives lasting protection against decay, mold, termites, powder post beetles and other wood-boring insects. Surfaces that will be further finished with paint, varnish, stain, etc., should be treated with Sunnyside Penta Water Repellent rather than Ready To Use Penta Preservative. Pines, red oak, basswood, black gum and ash take treatment well; aspen and cottonwood do not.

CAUTION! CONTAINS TECHNICAL PENTACHLOROPHENOL AND PETROLEUM DISTILLATE. If swallowed, do not induce vomiting. CALL PHYSICIAN IMMEDIATELY.

Keep away from heat and open flame. Do not breathe vapor or spray mist. Do not get in eyes, on skin, or on clothing. Wash thoroughly after handling. In case of contact with skin or eyes, flush repeatedly with copious amounts of water. Get medical attention. Close container after each use. Do not transfer contents to bottles or other unlabeled containers. Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place.
