**LABELING:** (Statements are based on review of referenced acute toxicity data)

- 1. The signal word is "DANGER"
- 2. Revise the Precautionary Statements to read:

**CORROSIVE:** Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

- 3. Revise the Statement of Practical Treatment to read:

**STATEMENT OF PRACTICAL TREATMENT.**

**IF SWALLOWED:** Drink promptly large quantities of water. Do not induce vomiting. Avoid alcohol. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

**IF IN EYES:** Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

**IF ON SKIN:** Wash with plenty of soap and water. Get medical attention.

### **DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

#### **DIRECTIONS FOR NEWLY FILLED POOLS**

Shock the pool to establish a residual chlorine value of 1.0-1.5 ppm. This dosage should be repeated until the test results for residual chlorine are in the range of 1.0-1.5 ppm. Sun-Screen protection and stabilization of chlorine in the pool is provided by stabilizer according to label instructions.

#### **REGULAR MAINTENANCE TREATMENT**

Adjust whatever proportioning mechanism that might be used to assure a constant treatment level of 1.0-2.0 ppm available chlorine in the pool water (normally 1 tablet per 7500 gallons weekly). The chlorine level should be checked daily with the use of a suitable test kit. Due to the daily changes in weather, temperature, and bather load, the frequency and the amount of tablets added will vary. Pool water pH must be adjusted and maintained regularly in the pH range of 7.2-7.8. For each pound of tablets, a half-pound of PLUS is added for pH control.

**STORAGE AND DISPOSAL:** Keep product dry in tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat or open flame. In case of decomposition isolate container in open area if possible, and flood with large amounts of water. Do not reuse empty container. Rinse empty container thoroughly with water to dissolve all material before discarding. Place in trash collection or dispose in approved landfill area. Do not contaminate feed, food or water by storage or disposal.
