Hazards to Humans and Domestic Animals.

**DANGER:** Corrosive. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. May be fatal if swallowed or absorbed through the skin. Harmful if inhaled. Wear safety glasses or goggles, protective clothing, and protective gloves. Avoid breathing vapors. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing before reuse.

## **ENVIRONMENTAL HAZARDS**

This pesticide is toxic to fish and aquatic organisms.

#### PHYSICAL AND CHEMICAL HAZARDS

Do not use or store near heat or open flame. Do not mix with soap or anionic materials

When Super Algi-Sea is used as directed it will kill and prevent development of *Cholera pyrenoidoisa* (green algae), *Phormidium retzii* (Square C algae), *Lyroba versicolor* (bluegreen algae) and other swimming pool algae.

Super Algi-Sea is compatible with most commonly used swimming pool chemicals but should not be mixed with other water-treating chemicals. Super Algi-Sea works best when added by itself to pool water.

## **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Ensure all equipment is working properly. Backwash the filter system following manufacturer's directions. Adjust pH between 7.2 – 7.6. Check for metals and if present, add stain and scale inhibitor to prevent staining of pool surface due to metals.

**Initial Dose:** Add 5 ½ oz of Super Algi-Sea per 10,000 gallons of water. Add the product directly into the pool by pouring around the entire outside perimeter of pool. Allow filter to run for at least six (6) hours after adding product. During this period, swimmers are not allowed into the water.

If algae growth is visible, apply initial dose. Then vacuum after 24 hours to remove dead algae. If algae is still visible, repeat dose as necessary until pool is free of visible algae.

Maintenance Dose: Add 1½ ounces of Super Algi-Sea per 10,000 gallons of water every 3-5 days or as needed. Allow filter to run 30 minutes after adding product. During this period, swimmers are not allowed into the water.

Booster Application: Apply 1 ½ quart-ounces per 10,000 gallons of water during prolonged rainfall or heavy bather loads. Allow the filter to run 30 minutes after adding product. During this period, swimmers are not allowed into the water.

If makeup water is added at more than 10% per week of capacity, add 6 ½ oz. of Super-Algi-Sea for each 10,000 gallons of fresh makeup water added per week. Add Super Algi-Sea directly to pool water. Never mix pool chemicals together.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store this product in a cool dry area, away from direct sunlight and heat to avoid deterioration. Do not store on side or inverted position.

**Pesticide Disposal:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide spray mixture or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by used according to label instructions, contact your state Pesticide or Environmental Control Agency of the Hazardous Waste representative at the neatest nearest EPA Regional Office for guidance.
