DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner which is inconsistent with its labeling.

NASCOTE is a black wood preservative designed to provide an appearance comparable to that of creosote. If a clear wood finish or subsequent painting are desired, use NASCO Clear Wood Preservative/Water Repellent for wood preservation.

NASCOTE protects wood against fungus growths which cause rot, decay and staining. It contains water repellents to aid in the control of shrinking, swelling, end checking, grain raising and warping.

For best results, NASCOTE should be applied by immersion so as to effect maximum penetration into the wood and heavy absorption especially at joints and wherever end grain exists. Allow five minutes of immersion per inch of wood thickness. If immersion is impractical, two heavy brush applications of this product should be applied allowing the first coat to penetrate thoroughly before applying the second. Treatment of end grain is especially important. All unsound wood should be cut out and removed two feet beyond any visible evidence of decay. All wood should be normally dry, and the framing or cutting completed before application of this product.

Estimated coverage: 5 to 10 gallons per thousand board feet for immersion; 100 to 300 square feet per gallon for brush application.

Protects the following types of wood: Shingles, millwork,

windows, doors, block flooring, decks, spars, docks, piers, house siding, fence posts, slats, staking material, and landscaping material.
