**Purpose** The purpose of this submission is to revise the label according to our previous letter, with one exception, and to include a statement accepting your September 29, 2006, Confidential Statement of Formula (CSF).

**CSF** Your CSF dated September 29, 2006, is acceptable, as modified by our previous letter. A copy has been placed in our files for this product. All other versions are obsolete.

**Review** In your letter you objected to adding the word "only" to the 1<sup>st</sup> Sentence of your "**USE RESTRICTIONS**" so that it would read, "This product may only be used to control Norway rats, roof rats and house mice."

You objected because you believed that the word is not found on any of your labels and those of your competitors.

We need qualifying statements, such as the one mentioned in our letter, to insure that applicators do not apply the product for uses other than those listed on the label under section 2(ee). Without such statements, applicators could use the product for uses for which we have not evaluated the hazards and risks. Such statements currently appear on

	other rodenticide labels and will occur on more labels in the future.
	As you are aware, the Agency is currently beginning the process of implementing risk reduction measures for structural and nonstructural uses that may result in additional restrictions. To the extent possible, we will attempt to apply restrictions at the same for similar types of products.
Label	The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following change, before you ship your product.
	<ol> <li>Revise the 1<sup>st</sup> Sentence of your "USE RESTRICTIONS" to read, "This product may only be used to control Norway rats, roof rats and house mice.</li> </ol>
Existing stocks	Stocks of existing labels may be used for eighteen (18) months.



To discourage reinfestation, limit sources of rodent tood, water and harborage as much as possible. If reinfestation does occur, repeat treatment. For a continuous infestation, set up permanent buit stations and replenish bait as needed. (27206)
