- Purpose This application, under section 3 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), submits data to support a change in the manufacturing establishment and an increase in the purity of active ingredient from 97.6% to 98.6%. In addition, you requested to modify the Personal Protective Equipment (PPE) text in your "PRECAUTIONARY STATEMENTS".
- **Data Review** In support of this request, you submitted product chemistry data, a revised Confidential Statement of Formula (CSF) dated February 21, 2005, and a revised label.

Your revised CSF is acceptable. We have placed a copy in the files for this product. All other versions are obsolete.

However, you will need to submit the following additional information within one (1) year of receipt of this letter:

- 1. a replacement study for the Preliminary Analysis (830.1700), conducted under full GLP requirements, including quality assurance procedures and
- 2. a replacement page of Step 8 of the manufacturing process, adding the identity and amount of the 2<sup>nd</sup> of two reactants.
