Maintain a constant supply of fresh bait for at least 15 days or until signs of mouse activity cases activity cease.

Rats: Apply 4 to 16 curacs of bait per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

Follow-un: Peplace contaminated or spoiled bait immediately. Wearing gloves, collect and dispose or all visiole dead animals and leftover bait, as wall as any bail that has become accessible to non-target animals. To discourage reinfestation limit sources of tode, at food, water reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment. For a continuous infestation, set up permanent bait stations and replenish bait as needed. (08907)
