Purpose	This submission, under section 3 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), adds burrows/sewers as sites; adds a wrapper to each block; and includes a label for a "mouse only" product.
Data	We have reviewed the previously submitted studies (MRID Nos. 454620-01 and -02) in relation to this current amendment. Assuming that the type of wrapper used in the tests for EPA Reg. No. 7173-235 is the same type of wrapper to be used for EPA Reg. No. 731-218, the claims for the sewer and burrow use are acceptable.
Label	The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable, with the following changes:
	1. In the "Note", change "lowered" to "prolonged".


