On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Rodenticide Cluster Reregistration Eligibility Decision, EPA has reregistered the product listed above. This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

Generic data requirements that have been identified in the RED as confirmatory data for the active ingredient contained in the subject product will continue to be tracked and assessed in the Agency's continual reassessment of pesticides.

1. Change the signal word from **“WARNING”** to **“DANGER”**, add **“POISON”**, add Skull and Crossbones, and revise the text as follows:

Fatal if inhaled. May be fatal if swallowed or absorbed through the skin. Do not breathe dust. Do not get in eyes, on skin, or on clothing. Wash hands, arms and face before eating, drinking, chewing gum, using tobacco or using the toilet. Avoid exposure to this product during pregnancy. Repeated exposure to small amounts of this product can cause cumulative toxicity. Check prothrombin times of persons at risk periodically.

Personal Protective Equipment (PPE) text for a manufacturing-use product is optional.

2. In the **“Note to Physician or Veterinarian:”**, change **“lowered prothrombin times”** to **“elevated prothrombin times”**.

3. Revise your use directions as follows:

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling:

Only for formulation into a rodenticide for

- i. the following uses: in and around buildings, inside transport vehicles, in sewers (Norway rat, roof rat, and house mouse); vineyards; orchards and groves; rangelands (bait stations or spot baiting around burrow entrances); forestry plantations; and selected noncrop areas,
- ii. uses for which USEPA has accepted the required data and/or citation of data that the formulator has submitted in support of registration; and
- iii. Experimental Use Permits that are in compliance with the requirements of the U.S. Environmental Protection Agency.

Formulators using this product are responsible for obtaining EPA registration for their formulated product.

4. Follow Enclosure 2, **“Minimum Type Sizes for Final Printed Label”**. Also, **“Skull and Crossbones”** and **“POISON”** must in red text.

5. Under “**STORAGE AND DISPOSAL**”, revise the text for “**Pesticide Disposal**” to that approved on the February 7, 1996, which reflects the correct text for a Category 1 product.
