1. Revise the 1<sup>st</sup> Sentence of your "USE RESTRICTIONS", wherever it occurs, to read, "This product may **only** be used to control ...."
2. Revise the 2<sup>nd</sup> Sentence under "CAUTION", wherever it occurs, to read: "May be harmful if swallowed or absorbed through the skin because it may reduce the clothing ability of blood and cause bleeding."
3. On the full place pack label, add this 2<sup>nd</sup> Sentence after "READ THIS LABEL": "It is illegal to sell these placepacks individually."

- 4. Delete the optional marketing claim, "Newest second-generation, single-feed anticoagulant rodenticide."
