Purpose

The purpose of this submission is to revise the label of this product, under section 3 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA).

Review

In your letter you objected to the following sentence on your "full label" place pack: "It is illegal to sell these placepacks individually." because other products do not have this sentence. We are requiring the sentence on this and other products because we have documented that some stores will break the original package and sell the products individually. In the future we will see more products having this sentence for placepack products.

Label

The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following change, before you ship your product.

1. Revise the number of rats controlled by the following package sizes as follows: 4.5 oz package size, 1-3 rats; 6 oz package size, 2-5 rats; 7.5 oz package size, 2-6 rats; 9 oz package size (3-7 oz package size; 12 oz package size, 3-9 rats; and 15 oz package size (4-12 rats).

- 2. On the "Full label" place pack label, add the following after the misuse statement ("It is ... with its labeling."): "It is illegal to sell these placepacks individually."
- 3. Under "WARRANTY", for all variations of this product, add the following text at the beginning of this section: "To the extent consistent with applicable law, …"
- 4. Revise the 1st Sentence of your "USE RESTRICTIONS" to read, "This product may **only** be used to control Norway rats, roof rats and house mice.
