Hazard to Humans and Domestic Animals

CAUTION: Harmful if swallowed, absorbed through the skin, or inhaled. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Avoid breathing dust. Keep away from children, domestic animals and pets. Wear waterproof gloves when handling bait or dead rodents. Wash arms, hands, and face with soap and water after handling bait or bait station.

FIRST AID

Have this label with you when obtaining treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. Call a poison control center or doctor immediately for treatment advice.

For humans or animals that have ingested this product or have obvious poisoning symptoms (bleeding) or prolonged prothrombin times, give Vitamin K₁ by intramuscular or oral administration. **ENVIRONMENTAL HAZARDS:** This product is extremely toxic to mammals and birds. Dogs, cats and other predatory and scavenging mammals and birds might

be poisoned if they feed upon animals that have eaten this bait.

Pesticide storage: Store only in original container in a cool, dry place inaccessible to children and pets. Disposal: Nonrefillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency for disposal instructions. USE RESTRICTIONS: THIS BAIT STATION IS NOT TAMPER-RESISTANT. DO NOT USE THIS PRODUCT OUTDOORS, OR IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, OR NONTARGET WILDLIFE. This product may only be used to control house mice inside homes, industrial, commercial, agricultural and public buildings. For use in non-food/non-feed areas. Do not contaminate human or pet food preparation items or areas. Do not place near or inside ventilation duct openings.

Selection of Treatment Areas: Determine areas where mice will most likely find and consume bait. Generally, these are along walls, by gnawed openings, in corners and concealed places, between floors or walls, or in locations where house mice or their signs have been seen. Remove as much alternative food as possible.

APPLICATION DIRECTIONS:

Remove bait station from package and place in horizontal position with side against wall, exposing entrance. Space stations 8 to 12 feet apart along walls or in corners where mice or their signs have been seen. Move placements not touched after three days to new locations where mouse activity is evident. Maintain a constant supply of fresh bait for 15 days or until signs of house mouse activity cease. Replace bait stations if contents are consumed or contaminated. Wearing waterproof gloves, collect and dispose of all visible dead animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment.
