Use 3 bait stations indoors in an average size room. For heavier ant infestations, use 6 bait stations. Place bait stations where ants have been seen, near ant trails and points where ants can enter building, and in out-of-the-way locations under cabinets, sinks and refrigerators. The clear view cap allows for easy inspection of ant activity. Replace bait stations immediately when bait station is empty or near empty. Heavy ant infestations may require additional bait stations. When ants find the bait, do not interfere with the eating process because the ants must carry the bait back to the colony to feed to the other ants. Place additional bait stations where there is heavy ant feeding activity.

RESTRICTIONS:

- Do not apply insecticide spray in the vicinity of the bait stations, as this will interfere with the ant's feeding and render the bait ineffective.
- Do not apply to areas that are easily accessible to children and pets.
- Do not apply to surfaces used for food preparation, dishes, utensils or food containers.
