

- On page 2, under “Directions for Use,” revise the statement that reads “Do not apply insecticide spray in the vicinity of the bait stations” to read “Do not apply insecticide spray in the vicinity of the bait stations as the bait will be rendered ineffective.”
- On page 2, under “Directions for Use,” make a section titled “**Restrictions:**” for prominence and move the following statements under it:
  - “Do not contaminate food or food preparation surfaces, dishes, utensils or food containers.
  - “Do not apply insecticide spray in the vicinity of the bait stations as the bait will be rendered ineffective.”

In addition, add the following restrictions to this section:

- “Do not use in beehives.”
  - “Do not apply in locations of high temperature or direct sunlight as the bait will be rendered ineffective.”
- On page 3, revise the claim “Use indoors and outdoors” to read “Use indoors.” The efficacy data supports use both indoors and outdoors, however the Child Resistant Testing (CRP) only supports indoor use. If further CRP testing is conducted and outdoor use is approved, you may add “outdoors” to the label.

3. Storage stability (830.6317) and corrosion characteristics (830.6320) data must be submitted within 18 months from the date of this registration notice. A citation of this data is not applicable since this data is specific to packaging.

4. Submit one copy of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). These ready-to-use bait stations contain a bait formulation that is very effective at controlling German cockroaches inside of homes and residential structures.

For thorough cockroach control, place up to 10 bait stations at one time. Place the bait stations in locations where roaches have been observed. Typically, roaches harbor in places where food and water are available. Place bait stations along wall baseboards, in corners, behind or under sinks and appliances, near plumbing fixtures and trash containers, and inside of closets and cabinets. Cockroach bait stations work best on horizontal surfaces touching corners and walls. These bait stations fit snugly in corners and along paths travelled by roaches.

Do not contaminate food or food preparation surfaces, dishes, utensils or food containers. Do not apply insecticide spray in the vicinity of the bait stations.

Roaches attracted to the bait will begin to feed immediately and will begin to die within hours. Roaches eat the bait and return to their hiding places to die, Bait carried back to the nest continues to kill other roaches. If cockroaches are seen in other rooms, use additional bait stations where the roach activity has been observed.
