PRECAUTIONARY STATEMENTS

Hazard to Humans and Domestic Animals

CAUTION: Harmful if swallowed, absorbed through the skin, or if inhaled. Avoid contact with eyes, skin or clothing. Avoid breathing dust. Keep away from children, domestic animals and pets. User Safety Requirements: Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet, and change into clean clothing. **FIRST AID:** Have this label with you when obtaining treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. ENVIRONMENTAL HAZARDS: This product is extremely toxic to mammals and birds. Dogs, cats and other predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment wash water or rinsate.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL and follow all use directions and precautions. Only use for sites, pests, and application methods specified on this label.

IMPORTANT: Do not expose children, pets or other nontarget animals to rodenticides. To help prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals, and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, other potentially destructive animals, or in areas prone to vandalism.
- 3. Dispose of product container, unused, spoiled, and unconsumed bait as specified on this label.

USE RESTRICTIONS INSIDE OF AND WITHIN 50 FEET OF BUILDINGS: This product may only be used to control Norway rats, roof rats and house mice in and around homes and residential buildings, food processing facilities, industrial, commercial, agricultural and public buildings, and similar man-made structures. It may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. This product may also be used in alleys. Do not apply further than 50 feet from buildings. Do not sell this product in individual containers holding less than 4 pounds of bait. Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment. Do not broadcast bait.

USE RESTRICTIONS IN OUTDOOR, NONCROP AREAS, INCLUDING AREAS MORE THAN 50 FEET FROM BUILDINGS: This weather-resistant product may only be used to control Norway rats, roof rats and house mice in outdoor noncrop areas, such as fence lines, gullies, ditches, railroad rights-of way, garbage dumps, landfills and recycling facilities. This product must not be applied directly to food or feed crops, but may be applied on border areas and buffer strips adjacent to crops. All placements must be in tamper-resistant bait stations or placed deeply into rat burrows. Do not broadcast bait. Do not apply product if heavy rain or flooding would result in contaminating aquatic environments.

SELECTION OF TREATMENT AREAS: Determine areas where rats or house mice are likely to find and consume bait, such as along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors or walls, or locations where rodents or their signs are seen. Remove as much alternative food as possible.

APPLICATION DIRECTIONS:

House Mice: Apply 1 block per placement, usually spaced 8 to 12 feet apart. Up to 2 blocks may be needed at points of very high house mouse activity. Maintain a constant supply of fresh bait for 15 days or until signs of house mouse activity cease.

Rats: Apply 3 to 16 blocks per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

For sewer applications, securely attach one end of a wire to bait block and the other end to a stationary structure such as the bottom step of manhole ladder or to a sewer grate, allowing just enough wire for bait to rest on manhole benching. If benching is not present, suspend bait a few inches above the high water line or place bait on a board supported by opposing steps of the ladder. Securing bait in this manner will minimize chance for removal by rats or water. Place at least 16 blocks per manhole.

Follow-up: Replace contaminated or spoiled bait immediately. Wearing waterproof gloves, co!loct and dispose of all visible dead animals and leftover bait, as well as any bait that has become accessible to non-target animals. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. For a continuous infestation, set up permanent bait stations and replenish bait as needed.
