**IMPORTANT:** Do not expose children, pets or other nontarget animals to rodenticides. To help prevent accidents:

1. Store product not in use in a location out of reach of children and pets.

2. Apply bait in locations out of reach of children, pets, domestic animals, and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, other potentially destructive animals, or in areas prone to vandalism.

Maintain a constant supply of fresh bait for 15 days or until signs of activity cease. Rats: Apply 9 to 45 pouches per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

Maintain a constant supply of fresh bait for 15 days or until signs of activity cease. Rats: Apply 7 to 37 pouches per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

Application Directions for 0.7 oz. (20 g) size:

Each pouch contains 0.7 oz. (20 g)

House Mice [Mice and Meadow Voles\*]: Apply 1 pouch per placement, usually spaced 8 to 12 feet apart. Up to 3 pouches may be needed at points of very high activity. Maintain a constant supply of fresh bait for 15 days or until signs of activity cease. Rats: Apply 4 to 22 pouches per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

Application Directions for 1.0 oz. (28 g) size: Each pouch contains 1.0 oz. (28 g)

House Mice [Mice and Meadow Voles\*]: Apply 1 pouch per placement, usually spaced 8 to 12 feet apart. Up to 2 pouches may be needed at points of very high activity. Maintain a constant supply of fresh bait for 15 days or until signs of activity cease. Rats: Apply 3 to 16 pouches per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

Rats: Apply 2 to 11 pouches per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until signs of rat activity cease.

**Follow-up:** Replace contaminated or spoiled bait. Wearing waterproof gloves, collect and dispose of all visible dead animals and leftover bait, as well as any bait that has become accessible to non-target animals. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. For a continuous infestation, set up permanent bait stations and replenish bait as needed.

#### Optional label statement(s) for all sizes:

Bait may be removed from the pouch and placed in a feeding device that secures the unwrapped bait in a bait station. Discard empty wrapper in the trash.

Pouches can be secured in a bait station, skewered on a wire and placed between or below floor slats, or on a nail (in locations out of reach of children, pets and nontarget animals).
