Your Amendment Dated October 18, 1990

The amendment referred to above, submitted in connection with registration under FIFRA, is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Above "SPECIAL INSTRUCTIONS FOR CLEANING AND DECONTAMINATION . . ." a statement should be included KILLS HIV PRE-CLEANED ENVIRONMENTAL SURFACES/OBJECTS PREVIOUSLY SOILED WITH BLOOD/ BODY FLUIDS in health care settings or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of human immunodeficiency virus Type 1 (HIV-1) (associated with AIDS).
 - b. On the front label, under the "Physical or Chemical Hazards" heading, include the statement to read "Exposure to temperature above 120 °F may cause bursting."
2. Ask your supplier of perfume J79-293 to submit to this Agency a complete chemical composition, Material Safety Data Sheet and Health Effects, and for each component in the mixture chemical name, CAS Registry Number, and percentage or range in the percentage in the mixture.


3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

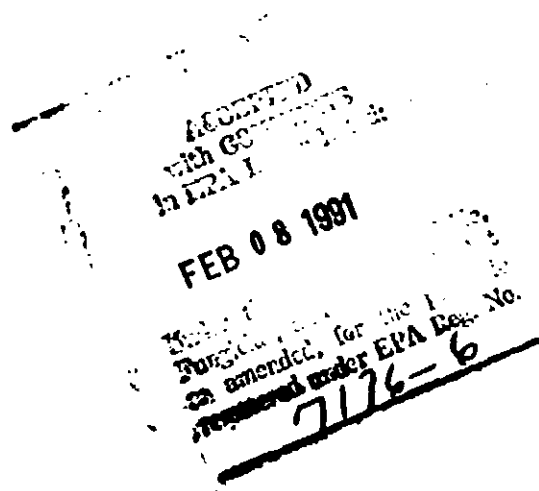

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Bright Disinfectant Foam Cleaner cleans and disinfects walls, sinks, tables, cabinets, tubs, fixtures, and other hard surfaces, including porcelain, ceramic tile, vinyl, enamel, formica, marble, and chrome. For use in hospitals, nursing homes, schools, hotels, offices and most any facility.

1. Shake can before using.
2. Spray on foam evenly.
3. Let foam remain wet for 10 minutes.
4. Wipe clean with damp cloth or sponge. No rinse needed.

An effective disinfectant against *Staphylococcus aureus*, *Salmonella choleraesuis*, and *Pseudomonas aeruginosa*.

Also an effective cleaner and disinfectant in the presence of organic soil (5% blood serum).

Fungicidal against pathogenic fungus (*Trichophyton mentagrophytes*) when used as directed on hard surfaces found in the bathroom, shower stall, and locker room, or other clean hard nonporous surfaces.

Controls mold and mildew and the odors they cause on hard nonporous inanimate surfaces.

Kills HIV-1 (Human Immunodeficiency Virus Type 1) which causes AIDS (Acquired Immunodeficiency Syndrome). Against HIV-1 this product is virucidal after 1 minute contact time in the presence of organic soil (10% blood serum). To kill other organisms listed on this label, allow surface to remain wet for 10 minutes.

Special Instructions for Cleaning and Decontaminating Against HIV-1 (AIDS virus) on Surfaces and Objects Soiled with Blood or Bodily Fluids

Personal Protection: When handling items soiled with blood or bodily fluids, wear disposable latex gloves, gowns, masks, and eye coverings.
