DIRECTIONS FOR USE

Best results would be obtained by using wood pressure-treated with our product PENWAR. In the u of that next best results will be obtained by immersing wood to be treated in PENWAR for 3 minutes or longer if wood is in excess of 1" thickness. Wear protective clothing and rubber gloves when handling the freshly treated lumber. Where dipping is not possible two or more flowing coats of PENWAR should be made. Rewet wood surface with PENWAR immediately after application to give higher retentions and better penetration. Allow at least 24 hours and preferably longer before application of varnish or paint. Brush, spray or dip to obtain maximum absorption on cut surfaces.

Wood in exterior or interior locations or any uses where subject to decay and insect attack. For use on wood in place. For use on millwork, sash, exterior doors, boat hults, pallets, eaves, fascia, shingles, siding, plywood and signs. Also, on boxes, crates, trellises, window frames. For protection against subterranean termires treat wood prior to placement in construction.


