DIRECTIONS FOR USE

FOR CONTROL OF ANTS, ARMYWORMS, CRICKETS, EUROPEAN EARWIGS, SPIDERS, CHIGGERS, AND TICKS, apply 6 lbs. of this product per acre to lawns, other grassy areas, ornamental plants and nursery stock.

FOR CONTROL OF JAPANESE BEETLE LARVAE, WHITE FRINGED BEETLE LARVAE, WHITE GRUBS AND WIREWORMS, apply 10 lbs. this product per acre for a single season control. 4 to 5 years control may be obtained with applications of 21 to 35 lbs. per acre dosage. Wash into the soil or turf following application.

CRABGRASS PREVENTION: As an early season preventive treatment for Crabgrass, apply 6 lbs. this product per 1000 sq. ft. This treatment is not effective for the control of Crabgrass plants. The application must be made prior to the time any germination or sprouting occurs. Timing of application is important. This treatment will not burn or injure established lawns. Keep children and pets off treated areas until this material has been thoroughly washed into the soil and the grass has completely dried. Do not use on newly seeded lawns.
