

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

This product, when properly used, will give effective protection against the insects and mites for which it is recommended.

Dilute this product 1 gallon to 100 gallons of water before using. For smaller quantities use 2½ tablespoons to 1 gallon of water or 1 pint to 12 gallons of water.

Do not use this product in combinations with highly alkaline materials such as lime or lime sulfur. Do not use in combinations with any other pesticide not compatible with solvent base formulations.

This product is effective for control of bagworms, canker worms, walnut caterpillars, European red mite, clover (bryobia) mite, red spider mite or two-spotted mite, six-spotted mite, strawberry mite, cyclamen mite and privet mite.

This product may be used on all species of pine, juniper, most deciduous ornamental trees and shrubs, roses, azalea, chrysanthemum, cyclamen, dahlia, lily, gardenia, gladiolus, ivy, snap dragon, and Sweet William.

Spray plants thoroughly to insure full and complete coverage of all foliage.

STORAGE AND DISPOSAL

PROHIBITIONS

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

PESTICIDE DISPOSAL


