This product is for use only by Mosquito Abatement Districts, Public Health Officials, Public Mosquito Control Officials and Commercial Pest Control Operators.

Read the entire label before using this product. As a thermal fog application for adult mosquito control apply with a standard fogging machine calibrated to deliver 40 gallons per hour at a machine speed of 5 miles per hour to cover a swath width of up to 350'. Repeat as necessary.

For airplane application as a control for adult mosquitoes, apply 1 gallon of this product per acre treated. Allow at least three weeks between applications.

FISH & WILDLIFE CAUTION

This product is toxic to fish and wildlife and birds. Keep out of lakes, streams or ponds.

Do not apply when weather conditions favor drift from areas treated.

Do not contaminate water by cleaning of equipment, or disposal of wastes.
