General Information on the Use of this Product

Chemicals for soil treatment are used to establish a barrier which is repellant to termites. The chemical emulsion must be adequately dispersed in the soil to provide a barrier between the wood in the structure and the termite colonies in the soil.

It is necessary for the effective use of this product that the service technician be familiar with current control practices including trenching, rodding, subslab injection, and low pressure spray applications. These techniques must be correctly employed to prevent or control infestations by subterranean termite species of Reticulitermes, Zootermopsis, Heterotermes, and Coptotermes. Choice of appropriate procedures includes consideration of such variable factors as the design of the structure, water table, soil type, soil compaction, grade conditions, and the location and type of domestic water supplies. The biology and behavior of the involved termite species are importantactors to be known as well as suspected location of the colony and severity of the infestation within the structure to be protected.

For advice concerning current control practices for specific local conditions, consult resources in structural pest control.

Contamination of public and private water supplies must be avoided by 'following these precautions:

Use antiback-flow equipment or precedures to prevent siphonege of pesticide back into water supplies.

Do not treat structures that contain cisterns or wells.

Do not treat soil that is water saturated or frozen.

Consult state and local specifications for recommended distances of treatment areas from wells, and refer to Federal Housing Administration Specifications for further guidance.

All nonessential wood and cellulose containing materials, including scrap wood and form boards, should be removed from around foundations walls, crawl spaces, and porches. This does not include existing structural soil contact wood that either has been or needs to be treated.

PRECONSTRUCTION SUBTERRANEAN TERMITE TREATMENT

Effective preconstruction subterranean termite control requires the establishment of an unbroken vertical and/or horizontal chemical barrier between wood in the attuiture and the termite colonies in ***** the soil.

To meet F.H.A. termite proofing requirements, follow the latest edition of the Housing and Orban Development (H.U.D.) Minimum Property Standards.

Mix 2 pints of this product in 23 gallons of water to produce a 1% water emulsion. Use a 1% water emulsion for subterranean termites.

Where necessary, use # 2% water emulsion for Coptotermes app. For # 2% emulsion, mix l pist of this product in 23 quarts of water.

After grading is completed and prior to the pouring of the slab, slab supported/constructed porches or entrance platforms, make the following treatments. Applications shall be made by a low pressure spray for horizontal harriers over areas intended for covering floors. porches and other critical areas.

Establish a vertical barrier in areas such as around the bar of foundations, plumbing, back-filled noil against foundation walls and other critical areas.

- Where it is necessary to produce a horizontal barrier, apply the emulsion at the rate of 1 gallon per 10 square feet to fill dirt. If fill is washed gravel or other coarse material, apply at 1 1/2 gallons per 10 square feet. It is important that the emulsion reaches the soil substrate.
 - If concrete slabs cannot be poured over soil the same day it has been treated, a water-proof cover, such as polyethylene sheeting, should be placed over the soil. This is not necessary if foundation walls have been installed around the treated soil.
- To produce a vertical barrier, apply the emulsion at the mate of 4 gallons per 10 linear feet per foot of depth.
 - Rodding and/or trenching applications should not be made beolow the top of the footing.
 - Trench need not be wider than 6 inches.
 - hod holes should extend from the base of the trench to the top of the footing, and should be spaced (about a foot) to provide a continuous barrier.
 - d. Emulsion should be mixed with the soil as it is being replaced in the trench. Cover treated soil with a layer of untreated.----soil, or other suitable harrier such as polyethylene sheeting,
- Hollow block foundations or voids of masonry should be treated *6"." make a continuous chemical barrier in voids. Apply at the rate of 2 gallons of emulsion per 10 linear feet so it will reach the footing.

- 4. For crawl spaces apply at the rate of 4 gallons of emulsion per 10 linear feet and foot of depth from grade to hottom of foundations. Application may be made by rodding and/or tranching (utilizing low pressure spray). Treat both sides of foundation and around all piers and pipes.
 - a. Rod holes should be spaced (about 1 foot) to provide a continuous chemical barrier.

b. Tranch need not be wider than 6 inches nor below the foundation. The emulsion should be mixed with the soil as it is being replaced in the trench. Cover the treated soil with a layer of untrested soil or other suitable parrier such as polyethylene sheeting.

POSTCONSTRUCTION TREATMENTS

Mix 2 pints of this product in 23 gallons of water to produce a 1% water emulsion. Use a 1% water emulsion for subterranean termites.

Where necessary, use a 2% water emulsion for Coptotermes app. For a 2% emulsion, mix 1 pint of this product in 2% quarts of water.

Postconstruction applications shall be made by injection, rodding, and/or trenching (using low pressure spray).

Do not apply emulsion until location of heat or air conditioning ducts, vents, water and sewer lines and electrical conduits are known and identified. Extreme caution must be taken to avoid contamination of these structural elements and airways.

- 1. For alab-on-ground construction apply at the rate of 4 gallons of emulsion per 10 linear feet. Applications may be made by subslab injection and/or trenching. Injectors should not extend beyond the tops of the footings. Treat along the outside of the foundation and where necessary just beneath the alab on the inside of foundation walls. Treatment may also be required just beneath the alab along one side of interior partitions and along all cracks and expansion joints.
 - Drill holes in the glab to provide a continuous chemical barrier.
 - b. Where necessary, drill through the foundation walls from the outside and force the emulsion just beneath the slab either along the inside of the foundation or slong all the gratks and expansion joints and other critical areas.
 - e. For shallow foundations, I foot or less, dig a narrow trench approximately six inches wide along the outside of the foundation walls. Do not dig below the bottom of the foundation. The emulsion should be applied to the trench and the soil at 4 gallons per 10 linear feet as the soil is replaced in the trench. Cover the treated soil with a layer of untreated soil.

- Hollow block foundations or voids of masonry should be treated to make a continuous chemical barrier in voids. Apply at the rate of 2 gallons of emulsion per 10 linear feet.
- 3. For basements apply at the rate of 4 gallons of emulsion per 10 linear feet. Where footings are greater than 1 foot of depth from the grade to the bottom of the foundation application may be $mad \in \$ by trenching and/or rodding at the rate of 4 gallons of emulsion per 10 linear feet per foot of depth. Treat outside of foundation walls, and if necessary beneath the basement floor along inside of foundation walls, along cracks in basement floors, along interior load bearing walls, round sewer pipes, conduits, and pierm.
- In crawl spaces apply at the rate of 4 gallons of emulsion per 10 linear feet per foot of depth from grade to bottom of foundation. Application may be made by rodding and/or trenching (utilizing low pressure spray). Treat both sides of foundation and around all piers and pipes.
 - Rod holes should be spaced (about 1 foot) to provide a continuous chemical barrier.
 - Trench need not be wider than 6 inches nor below the foundation. The emulsion should be mixed with the soil as it is replaced in the trench. Cover the treated soil with a layer of untreated soil or other suitable barrier such as polyethylene sheating.
 - For inaccessible crawl spaces, treat soil by an alternate method such as drilling and rodding through foundation walls from the outside.

 $\pi^{m{j}}$, All treatment holes drilled in construction elements of living areas of homes should be securely plugged.

RETREATMENT RESTRICTIONS

- Retreatment for subterranean termites should only be made when there is evidence of re-infestation subsequent to the initial treatment, or there has been a disruption of the chemical barrier in the soil due to construction, excavations, landscaping, etc.
- Retreatments may be made to critical areas in accordance with the: ** application techniques described above. This application should" be made as a spot treatment to these areas.

Routing retreatment of the entire premises should be avoided.
