The application of 200 pounds or more of the weed killer per acre usually renders the soll non-productive for extended periods. The rapidity and uration of effect will vary with the amount applied, the soil type, rainfall and other local conditions.

For non-crop use, the application of 200-400 pounds per acre will provide practical weed control for a period of 6 months or longer. Under adverse conditions or when hard to kill weeds such as established Johnson grass are present or where longer term control is desired, apply larger quantities up to 800 pounds per acre. TERRATOX Industrial Weed Killer may be used at any time of year for general weed control, but for most satisfactory results should be applied just prior to or during seasons likely to have rainfall. It may be applied to dense weed growth; provided sufficient water is used but best results are obtained when applied to bare soil or mowed vegetation.

SPOT APPLICATIONS: For treatment of small areas where is desired to kill all vegetation, apply 1 to 2 lbs. to cover a 100 square foot area. Although intended primarily for application as a dry powder, TERRATOX Industrial Weed Killer may be mixed with water at the rate of 1 lb. per gallon and applied as a water suspension, making sure to keep the mixture well agitated.
