On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

2. Make the following label changes:

- c. On page 2 under "DIRECTIONS FOR USE", "INDOOR USE", insert the statement "Remove pets, birds, and cover fish aquariums before spraying."


- d. On page 4 under the section "PRECAUTIONARY STATEMENTS:" the statement "Hazard to Humans and Domestic Animals." should immediately follow. The signal word "CAUTION" must immediately follow the statement "Hazard to Humans and Domestic Animals."
- e. On page 4 under the section "PRECAUTIONARY STATEMENTS.", "STATEMENT OF PRACTICAL TREATMENT (SOPT):" the "(SOPT)" should be removed.
- f. On page 1 the statement "and is relatively non-toxic to honey bees", and on page 4 under "DIRECTIONS FOR USE", "FOR USE ON LISTED PLANTS -- INDOORS AND OUTDOORS:", "For the control of plant insects on contact:", "Dilute with water", the statement "This product is relatively non-toxic to honey bees." must be removed unless you can cite a substantially similar product on which these label claims are present.

3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Pyrethrins also have the added benefit of flushing these insects from their hiding places to aid in a more complete control.

Shaklee Insect Control, when diluted with water and sprayed according to directions, will control listed insects in specified areas. ~~This one product can be used effectively on a variety of pests.~~ Shaklee Insect Control effectively eliminates pests that infest kitchens including cockroaches, ants and other listed pests. It can be used on edible vegetables as well as ornamental plants outdoors and in the home and is relatively non-toxic to honey bees. When used according to directions it will also significantly help control dust mites.

**For use in or on:**

Ant hills, basements, bathrooms, bedrooms, boats, bookcases, cabinets, cabins, camp sites, campers, carpets, chests, porches, closets, decks, dog houses, dressers, floors, house plants, garages, garbage cans, gardens, living rooms, locker rooms, ornamental plants, pantry, patios, pet bedding, pet sleeping areas, pet carriers, residential greenhouses, rugs, storage areas, tents, trailers, utility rooms, vegetable plants, washrooms.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**READ ALL DIRECTIONS COMPLETELY BEFORE USE.**

**SHAKE WELL BEFORE USE.** This liquid concentrate must be diluted with water as directed for specific areas. Put correct amount of concentrate into a spray unit, add water as directed and mix well. Spray as directed. You may notice the pleasant scent of Shaklee Basic-H, D-limonene and garlic. Do not use on animals. When using on wood, on fabric, or on any non-washable surface always test in an inconspicuous area prior to use as the finish may be adversely affected by any liquid product. Do not contaminate food areas. After treatment, clean food preparation surfaces before preparation of food. Repeat if necessary.

**INDOOR USE:**

**FLEAS AND TICKS:** Dilute with water-- add 2 fluid ounces (4 tablespoons) of concentrate to 14 fluid ounces of water - and mix well. Prior to use, vacuum all infested areas thoroughly and dispose of vacuum bag in outside trash. Apply uniformly to infested areas and to places where pets frequent. Avoid excessive wetting of surfaces. Spray thoroughly into hiding places, such as cracks, crevices, walls, floors, baseboards, and window and door frames, contacting pests when possible. Repeat as necessary. Do not allow children or pets to walk on treated surfaces until completely dry. In pet areas remove pet's old bedding and either destroy or wash. To reduce infestations, thoroughly spray the animal's bedding, sleeping quarters, walls, cracks, floors and other resting places. Also spray the entire inside surface of dog houses. Put fresh bedding in pet's quarters after spray has dried. Repeat as necessary. Not approved for direct application to pets.

**COCKROACHES, CRICKETS, CENTIPEDES, FIREBRATS, SPIDERS** and other crawling insects: Dilute with water - 1 1/2 fluid ounces (3 tablespoons) of concentrate to 14 1/2 fluid ounces of water - and mix well. Contact as many insects as possible by thoroughly spraying all areas where pests are suspected of hiding. Pay special attention to hiding places: beneath sinks, behind and beneath stoves and refrigerators, around garbage cans, cabinets, baseboards, door sills, frames and floors, around and on drains, pipes, plumbing, behind bookcases, storage and other utility areas, hitting insects with spray when ever possible. Repeat as necessary. *Do not spray holes or face contact surface.*

**ANTS:** Dilute with water - 1 fluid ounce (2 tablespoons) of concentrate to 15 fluid ounces of water - and mix well. Treat around doors, window frames and other areas of entry. Spray on ants whenever possible. Repeat as necessary. *And*

**DUST MITES:** Dilute with water - 2 fluid ounces (4 tablespoons) of concentrate to 14 fluid ounces of water - and mix well. Prior to use, vacuum all infested areas thoroughly and dispose of vacuum bag in outside trash. Apply uniformly to infested areas. Avoid excessive wetting of surfaces. Spray thoroughly into hiding places such as pillows, sofas and carpets. Repeat as necessary.

For Use In Homes, Home Gardens, and Home Greenhouses

**OUTDOOR USE:**

Caution should be taken to avoid spraying when wind conditions could create a mist and blow back to applicator. Spray the upper and lower leaf surface areas and contact as many insects as possible. Do not apply this product in or around bodies of water.

**FLIES, GNATS, MOSQUITOES, SMALL FLYING MOTHS** and other flying insects: Dilute with water – 1 1/2 fluid ounces (3 tablespoons) of concentrate to 14 1/2 fluid ounces of water – and mix well. To reduce annoyance from these pests spray porches, patio areas, screens, window frames, doors and other areas where these pests may congregate. Hold sprayer 18 inches from shrubs, bushes, grass and other infested areas. Spray with a slow sweeping motion. Allow spray to dry before occupying the treated area. Repeat as necessary.

**ANTS:** Dilute with water – 1 fluid ounce (2 tablespoons) of concentrate to 15 fluid ounces of water – and mix well. Spray ant trails, ant mounds and other areas of entry and infestation. Spray on ants whenever possible. Repeat as necessary.

**SPIDERS:** Dilute with water – 1 1/2 fluid ounces (3 tablespoons) of concentrate to 14 1/2 fluid ounces of water – and mix well. Spray directly on spiders and webs. Repeat as necessary.

**SOWBUGS, MILLPEDES, BEETLES, EARWIGS** and other crawling pests: Dilute with water – 1 1/2 fluid ounces (3 tablespoons) of concentrate to 14-1/2 fluid ounces of water – and mix well. Spray surfaces thoroughly and spray into hiding places such as cracks, crevices, moist areas, openings around pipes, spigots, storage areas, sheds and other areas where these pests congregate.

**FOR USE ON LISTED PLANTS -- INDOORS AND OUTDOORS:**

For use on growing fruits and vegetables, on ornamental plants, indoors and outdoors, and in residential greenhouses: beans, berries, broccoli, cabbage, carrots, cilantro, cucumber, grapes, lettuce, melons, peas, peppers, potato, pumpkin, radish, raspberry, rhubarb, spinach, squash, strawberry, Swiss chard, tomatoes, zucchini and bok choy. Ornamental plants such as: African violets, asters, azalea, begonia, calendula, call, camellia, carnation, chrysanthemum, coleus, deciduous ornamentals, evergreens, ferns, fuchsia, gardenia, iris, jasmine juniper, lily, petunia, roses, salvia, snapdragon, spider plant and zinnias.

Trees, including ornamentals, pome fruits, stone fruits, citrus and shrubs.

**For the control of plant insects on contact:**

Aphid, armyworm, cabbage looper, caterpillars, Colorado potato beetle, cucumber beetle, gypsy moth inchworm, Japanese beetle, lace bug, leafhopper, leafroller, mealy bug, tent caterpillar, thrips, whitefly, tomato fruit worm.

Dilute with water – 1 fluid ounce (2 tablespoons) of concentrate to 15 fluid ounces of water – and mix well. Hold sprayer 18 inches from plants and spray thoroughly, contacting as many of the insects as possible on upper and lower leaf surfaces. Spraying should begin when the insects first appear. Do not wait until the plants are heavily infested. Avoid excessive wetting of foliage with spray. Don't spray when temperature exceeds 90F. Repeat as necessary. This product is relatively non-toxic to honey bees.

(To avoid possible harm to honey bees, it is advisable to apply in the early morning or late evening hours.)

**STORAGE:**

Keep in tightly closed original container. Store in a cool, dry place, preferably a locked storage area away from children and pets.

**DISPOSAL:**

To dispose of container after emptied through normal use, securely wrap original container in several layers of newspaper and discard in trash. Do not reuse empty container.

**PRECAUTIONARY STATEMENTS:**

Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling.

**STATEMENT OF PRACTICAL TREATMENT (SOPT):**

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

**ENVIRONMENTAL HAZARDS:**

This pesticide is toxic to fish. Do not apply directly to water. Do not contaminate water when disposing of equipment and when washing or rinsing equipment with water.

Combustible. Do not use or store near heat or open flame. Do not use this product or the diluted product in or on electrical equipment due to possibility of shock hazard.
