The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Tralopyril Interim Registration Review Decision, and has concluded that your submission is acceptable.

### **DIRECTIONS FOR USE:**

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

This product is intended to control attachment of barnacles, mussels, snails, tube worms, algae, slime and other marine fouling organisms on vessel hulls in salt and freshwater environments. Not for use on pleasure craft.

#### SURFACE PREPARATION

Surface to be painted shall be free of dirt, oil grease and other surface contaminants. Apply over a suitable primer system or clean, intact, existing antifouling coating. For recoating of approved systems, the antifouling substrate should be cleaned by means of low pressure water cleaning (1500-3000 psi). Corroded or damaged areas should be blast cleaned and repaired according to the original specification. Substrate temperature should be at least 5°F (3°C) above dew point.

## **APPLICATION INSTRUCTIONS**

- 1. Can be applied by brush, roller or airless spray.\*
- 2. Clean all application equipment with Sigma Thinner 21-06.
- Stir material thoroughly and continue stirring occasionally during application to ensure pigment suspension.
- 4. Thin only for workability using no more than 0-2% thinner.
- Apply a wet coat in even brush or roller strokes or spray passes, building the wet film thickness to achieve the recommended dry film thickness. Allow 4 hours dry time at 77°F (25°C) between coats. Allow 10 hours dry time at 77°F (25°C) before launching.
- Clean application equipment immediately after use with Sigma Thinner 21-06.
