Directions for Use: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use LURECTRON° SCATTERBAIT pellets around the following commercial areas only: commercial poultry houses, livestock barns, and feed lots, canneries, beverage producers, meat, poultry and food processing plants. Scatterbait pellets may also be used on walkways in caged layer houses.

For use as a Scatterbait: Scatter pellets at the rate of approximately ¼ pound of pellets per 500 ft², maintaining a spacing of 1-2 inches between pellets. Do not leave pellets in piles.

For use as a paste: Mix ¼ Ib of LURECTRON® SCATTERBAIT with 4.0 oz water, stir well and keep covered for a few hours. Apply paste with a brush on walls, window sills, support beams where flies usually land, such that poultry, cattle or other animals cannot come into contact with the paste.

For use in bait stations: LURECTRON® SCATTERBAIT pellets may be used in bait stations placed at least four [4] feet off the ground. One bait station for 500 ft² should provide control.
