

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

C-T-B 12 is used

in recirculating commercial and industrial water treatment systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5.1

C-T-B 12 per 1000 gallons

is recommended. Repeat initial dosage until control is effected.

Subsequent slug additions of 1.7

C-T-B 12 per 1000 gallons

every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store five drums high. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpack and should not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely toxic. Excess pesticide, spray mixture, or rinsate is a valuable commodity; wastes cannot be disposed of by use according to label directions.
