FORCE 50 PLUS is a non-metallic, non-foaming concentrated algicide that will provide algae control when used as directed.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TO CONTROL OR INHIBIT THE GROWTH OF SWIMMING POOL ALGAE:

Initial Dose:

Add 5 1/2 oz of Force 50 Plus per 10,000 gallons of water.

Maintenance Dose:

Add 3 oz of Force 50 Plus weekly to provide continuous protection.

IF VISIBLE ALGAE IS PRESENT:

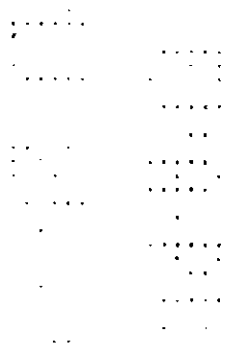
Treat with 5 1/2 oz of Force 50 Plus per each 10,000 gallons of pool water. Vacuum pool after 24 hours to remove settled algae debris. Repeat treatment if necessary.

TO CLOSE POOL AT THE END OF THE SEASON:

Add 5 1/2 oz of Force 50 Plus per 10,000 gallons of water to help control or inhibit the growth of swimming pool algae during winter months.
