In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by EPA. 3. **BLACK ALGAE CONTROL:** Apply [16 fluid ounces] [fl. oz.] for every 10,000 gallons of water when algae first appears. Brush spots daily to remove dead algae. Vacuum out settled algae.
4. **TO MAINTAIN POOLS FREE OF VISIBLE ALGAE GROWTH:** Use 4 to 8 [fluid ounces] [fl. oz.] of this product per 10,000 gallons of water weekly.

METHOD OF APPLICATION:

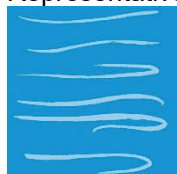

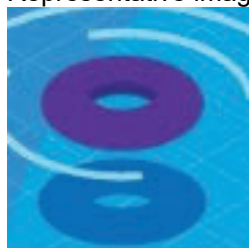
