In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

# SHAKE WELL BEFORE EACH USE

For maximum effectiveness, pools with a large amount of algae present must be cleaned prior to using this product. Pools having visible algae growth must be treated with 32 [fluid ounces][fl. oz.] per 10,000 gallons of pool water. After 24 hours, the algae debris must be removed by standard cleaning procedures, including brushing loose algae spots, vacuuming the pool and backwashing the filter.

For treatment of a freshly cleaned and filled pool, add 18 [fluid ounces][fl. oz.] per 10,000 gallons of pool water. To maintain pools free of visible algae growth, add 6 [fluid ounces][fl. oz.] per 10,000 gallons of pool water every week after the initial treatment. Apply this product directly to the pool water with the circulation system turned on. Allow ample time for product to be distributed before turning off the pump.

This product is compatible with other chemicals commonly used to treat swimming pools and it is effective in both acid and alkaline pH ranges. It can be used in pools treated with chlorine chemicals, and its use may reduce the amount of these chemicals required.

Compatible with bromine, chlorine, salt water, ozone, biguanide and minerals.

**IMPORTANT NOTE:** Always apply chemicals separately. Never combine them.
