Dear Joanna Holcombe:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Polixetonium Chloride (Busan 77) and the Zinc and Zinc Salts Interim Decisions, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12

months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process, FIFRA section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. Pools having visible algae growth must be treated with 32 [fluid ounces][fl. oz.] per 10,000 gallons of pool water. After 24 hours, the algae debris must be removed by standard cleaning procedures, including brushing loose algae spots, vacuuming the pool and backwashing the filter.

For treatment of a freshly cleaned and filled pool, add 18 [fluid ounces][fl. oz.] per 10,000 gallons of pool water. To maintain pools free of visible algae growth, add 6 [fluid ounces][fl. oz.] per 10,000 gallons of pool water every week after the initial treatment. Apply this product directly to the pool water with the circulation system turned on. Allow ample time for product to be distributed before turning off the pump.

Do not add more than 12 [fluid ounces][fl. oz.] per 10,000 gallons of pool water every week after the initial treatment.

This product is compatible with other chemicals commonly used to treat swimming pools and it is effective in both acid and alkaline pH ranges. It can be used in pools treated with chlorine chemicals, and its use may reduce the amount of these chemicals required.

Compatible with bromine, chlorine, salt water, ozone, biguanide and minerals.
