DIRECTIONS: WASH THOROUGHLY WITH WARM SUDS. USE 7.5 OZ. BLEACH PER 6 GALLONS OF WATER. SPREAD WITH CLOTH. LET STAND 2 MINUTES. RINSE WELL. (THIS IS A STANDARD DISINFECTING SOLUTION RECOMMENDED BY U.S. PUBLIC HEALTH SERVICE, 600PPM AVAILABLE CHLORINE.)

RESTAURANTS, DABRES, ETC.

1. SCRAPE AND PRE WASH UTENSILS AND GLASSES WHENEVER POSSIBLE.
2. WASH WITH A GOOD COMPATIBLE DETERGENT.
3. RINSE WITH CLEAN WATER.
4. SANITIZE IN A SOLUTION OF 2.5 OZ TO 6 GALLONS OF WATER (200PPM). IMMERS ALL UTENSILS FOR AT LEAST 2 MINUTES OR FOR CONTACT TIME SPECIFIED BY GOVERNING SANITARY CODES.
5. PLACE SANITIZED UTENSILS ON A RACK OR DRAINBOARD TO AIR DRY.

TABLE OF DILUTION: (AVAILABLE CHLORINE) 200PPM. USE 2.5 OZ PER 6 GALLONS OF WATER.
 NOTE: FS BLEACH WILL DEGRADE WITH AGE. TEST RINSE PERIODICALLY WITH A CHLORINE TEST KIT AND ADJUST DISPENSER RATE AS NECESSARY TO INSURE A MINIMUM OF 50 PPM AVAILABLE CHLORINE. DO NOT USE ON SILVER OR SILVER PLATE.
