Spas, whirlpool, or hot tubs having just visible algae growth require an initial dose of 10 to 15 fluid ounces of **AQUA CHEM SPA ALGICIDE** per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, or hot tub, add initially 7 to 10 fluid ounces of **AQUA CHEM SPA ALGICIDE** per 1000 gallons of water. For pools having just visible algae growth add an initial dose of 23.5 to 36.4 fluid ounces of N-680 Algae Control Conc per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 12.8 to 23.5 fluid ounces of N-680 Algae Control Conc per 10,000 gallons of water.
