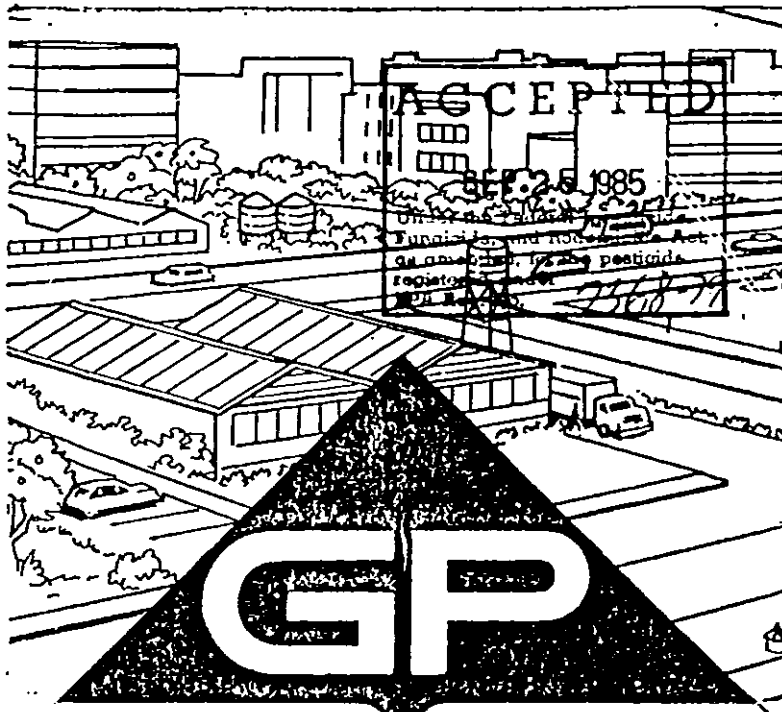

**DIRECTIONS**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SHAKE CAN WELL BEFORE SPRAYING. HOLD CONTAINER UPRIGHT.**

**To Kill Flies, Mosquitoes, Small Flying Moths and Gnats:** Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spraying 5 to 10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects. Before spraying cover exposed food and utensils.

**To Kill Cockroaches, Ants and Crickets:** Contact as many insects as possible directly with spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. For control of ants treat doors, window sills, and other areas of entry. Repeat as necessary for control.

**NOTE:** When used in hospitals, patients should be removed prior to treatment. Ventilate for two hours after treatment. Do not return patients until after ventilation.

**STORAGE:** Store in a cool dry area away from heat or open flame.  
**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.

**CAUTION**

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

Do not apply directly to food. In commercial food handling facilities, cover or remove any food and food processing equipment during application. Do not apply while food processing is under way. After space spraying in plants, bakeries, and other food processing plants, wash with potable water all equipment, benches, shelving, etc., where exposed food will be handled. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use.

Remove pets and birds, and cover fish aquariums before spraying.

**PHYSICAL HAZARDS**

Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Expose to temperatures above 130°F may cause bursting.
