DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Toilet Bowls: Force water over trap to empty bowl. Apply about 2 or 3 ounces to applicator and clean interior of units. Wet thoroughly. Flush and rinse surface and applicator.
Urinals: Pour 3 to 4 oz. into urinal. Apply to all surfaces including around drain outlet. Let stand 5 minutes. Flush and thoroughly rinse surface and applicator.

Quickly removes stains, incrustation and discolorations caused by lime deposits, rust and uric acid stains. Offensive odors are eliminated by removing odor causing gram negative and gram positive bacteria.
