1. WHAT IS THIS PACKAGE FOR?

This package of ferti-lone INSECT KILLER is for the control of CITRUS, SOB, SOD WEEB, FALL ARMYWORMS, EARRINGS, MILLIPLIPES, CHRISERS, TICKS, MOSQUITOES, ANTS, LEAFHOPPERS, AND FLEAS.

2. HOW DO YOU USE IT?

Treat the entire lawn or area evenly and thoroughly at the rate of 6 lbs. of ferti-lone INSECT KILLER per 1000 sq. ft. Apply with a spreader for uniform coverage. (See Spreader Setting below).

~~Apply 2 1/2 lbs. of ferti-lone INSECT KILLER per 1000 sq. ft. (This 30 lb. bag covers 4000 sq. ft.)~~

Work material in with a coarse water spray after treatment.
