1. WHAT IS THIS PACKAGE FOR?
Although formulated as a specific control for bagworms, you will find this new product useful for control of 48 other insects around your home garden, lawns and outdoor living areas.

2. HOW DO YOU USE IT?
Mix 1½ tablespoons in 1 gallon of water unless otherwise specified. Apply as a thorough foliar spray. Wet leaves and branches to the dripping point. Penetrate dense foliage. Repeat as necessary to maintain control.

EVERGREENS, ROSES, ORNAMENTALS, FLOWERS AND SHADE TREES:
Arborvitae, Junipers, Hollies, Rhododendrons, Azaleas, Camellias, Chrysanthemums, Mimosa, Boxwood, Lilac, Birch, Elm, Pine, Spruce, Maple, Douglas Fir, Hawthorn, Locust, Oak, Plum, Poplar, Carnations and Gladioli. To kill Bagworms, Aphids, Mites (Including Clover, Cyclamen, European Red, Privet, Two-Spotted Spider and Carnation Bud), Leafhoppers, Leaf Miners (Including Arborvitae, Azalea, Birch, Boxwood, Dipterous, Holly and Oak), Whiteflies, Mealy Bugs, Scale Crawlers (Including Cottony-Cushion, Lecanium, Pine Needle, San Jose, Soft and Euonymus), Thrips, Flea Beetles, Webworms (Including Juniper and Mimosa), European Pine Shoot Moths and Holly Bud Moths, apply as pests appear, repeating application as required. For Mimosa Webworms apply when adults appear, repeating twice at 4-5 week intervals. **NOTE:** Do not use on ferns, poinsettias, hibiscus, pleraras, gardenias, and orchids since plant injury may occur.

LAWNS:
ST. AUGUSTINE, BERMUDA, BLUEGRASS, DICONDRA, BENT, FESCUS, AND MERION: To kill Sod Webworms, Chinch Bugs, Cutworms, Armyworms, Lawn Moths, Ants, Chiggers, Fleas, Earwigs, Pillbugs, Crickets, Mites (both Bermuda and Clover), Springtails, Ticks, Frit Flies, Lawn Billbugs and Leafhoppers, water grass thoroughly a few hours before applying. Mix 5 tablespoons in 3 gallons of water and apply to 125 sq. ft. or 2½ cups in 24 gallons of water to 1000 sq. ft. **NOTE:** For Lawn Billbugs water lawn thoroughly immediately after application. In the north Chinch Bugs will be killed using 3 tablespoons in 3 gallons of water per 125 sq. ft.

NUISANCE PESTS: (In outside areas) To kill Ants, Roaches, Crickets, Flies, Chiggers, Clover Mites, Earwigs, Fleas, Millipedes, Scorpions, Pillbugs and Spiders, mix 2½ cups in 3 gallons of water. Spray a 5 ft. band of soil around the foundation and on the foundation of house to a height of 2-3 feet. Thoroughly spray window and door screens, sills, porch and patio walls and ceilings, entranceways, walks, garbage cans and into cracks and other places where insects hide. Do not treat plants or animals.

3. HERE ARE THE RESULTS YOU MAY EXPECT!
Rapid, long-lasting and economical kill of destructive bagworms and other listed insects may be expected when used as directed.

WARNING: May be fatal if swallowed or absorbed through the skin. Do not breathe spray mist. Avoid contact with skin, eyes, and clothing. Wash thoroughly after handling. Avoid contamination of feed and foodstuffs. Do not use on household pets or humans. Do not permit children or household pets to go onto sprayed grass or come in contact with foliage until spray has completely dried.

This product is toxic to fish and wildlife. Birds feeding on treated area may be killed. Keep out of any body of water. Do not contaminate water by cleaning of equipment, or disposal of waste.
