USE ONLY WHEN WEARING THE FOLLOWING PROTECTIVE EQUIPMENT AND CLOTHING

(1) Wear water proof pants, coat, hat, rubber boots or rubber overshoes (2) Wear safety goggles (3) Wear mask or respirator approved by the U.S. Bureau of Mines for parathion protection (4) Wear heavy duty, natural rubber gloves.

WORK SAFETY RULES

Keep all unprotected persons and children away from treated area or where there is danger of drift.

Do not rub eyes or mouth with hands. If you feel sick in any way, STOP work and get help right away. Call a doctor (physician), clinic or hospital—immediately. Explain that the victim has been exposed to parathion and describe his condition. After first aid is given (see First Aid Treatment Section) and if a doctor cannot come, take victim to clinic or hospital.

IMPORTANT! Before removing gloves, wash them with soap and water Always wash hands, face and arms with soap and water before smoking, eating or drinking.

AFTER WORK, take off all work clothes and shoes Shower, using soap and water. Wear only clean clothes when leaving job. Do not wear contaminated clothing. Wash protective clothing and protective equipment with soap and water after each use. Respirator should be cleaned and filter replaced according to instructions included with respirator.

DO NOT USE, POUR OR STORE NEAR HEAT OR OPEN FLAME.

POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are Headache, nausea, vomiting, cramps, weakness blurred vision, pin point pupils, tightness in chest labored breathing, nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma.

♣ FIRST AID TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition.

If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim. If swallowed and victim is awake (conscious) make him vomit quickly. Induce vomiting by sticking finger down throat or by giving soapy or strong salty water to drink. Repeat until vomit is clear. Never give any thing by mouth to an unconscious person. Have victim lie down and teep quiet. See doctor immediately.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. See doctor immediately.

NOTE TO PHYSICIAN



GENERAL DIRECTIONS

HI-YIELD BRAND 4 LB. METHYL PARATHION EMULSIFIABLE CONCENTRATE can be used in conventional hydraulic sprayers, low-volume ground applicators or airplane sprayers. Approximately 5-10 gallons of water per acre should be used with this product for application by airplane.

MIXING DIRECTIONS

Mix with water by agitation; agitate the mixture while spraying. If allowed to stand, re-agitate before use.

DIRECTIONS FOR USE

COTTON: For control of aphids, boll weevil, cotton leafworm, fleahopper, red spider, mites, and thrips, apply ½ pint to 1 pint per acre. Applications should be at 4-5 day intervals until control is obtained. Do not apply within 15 days of harvest.

SMALL GRAINS including barley, oats, rye, wheat: For control of aphids (green bugs) apply ½ to 1 pint per acre. Do not apply after heads begin to form In California use only ½ to 34 pint per acre.

ALFALFA, VETCH: For control of spotted alfalfa aphid apply at ½ to 1 imper acre in early spring. Do not apply within 15 days of harvest. In California the only 34 pint per acre.

CONTAINER DISPOSAL

To prevent re-use, empty containers to be decontaminated and destroyed. The grant taminate by washing thoroughly with a strong solution of alkali and detergent and runse with water.

Dispose of liquid wastes in a pit in non-crop lands located away from water sor, plies. Clean application equipment after each use by flashing with water
