

**1. WHAT IS THIS PACKAGE FOR?**

This package is for control of White Grubs (the larvae or worm stage of Asiatic Garden Beetle, European Chaffer, Green June Beetle and White Fringed Beetles) . . . some of the most destructive insects invading lawns.

Grubs feed in grass roots below soil surface. Their damage is indicated by dead areas of turf.

**2. HOW DO YOU USE IT?**

**LAWNS AND OTHER GROUND COVERS:** Water grass thoroughly a few hours before applying. Mix 6 teaspoons in 1 gallon of water and apply to 125 sq. ft. (or 1 cup in 24 gallons of water per 1000 sq. ft.). Repeat as necessary to maintain control.

**3. HERE ARE THE RESULTS YOU MAY EXPECT!**

White Grub control in your lawn areas is easily obtained with use of this product.

**WARNING:** May be harmful or fatal if swallowed or absorbed through the skin. Do not breathe spray mist. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Avoid contamination of feed and foodstuffs. Do not use on household pets or humans. Do not permit children or household pets to go onto sprayed grass or come in contact with foliage until spray has completely dried.

**DO NOT USE, POUR, SPILL OR STORE NEAR HEAT OR OPEN FLAME.**
