1. WHAT IS THIS PACKAGE FOR?

ferti-lome WEED KILLER PLUS LAWN FOOD is for the lawn that has become infested with unsightly weeds.

2. HOW DO YOU USE IT?

Apply using fertilizer spreader set from chart below. Make application when weeds are in active growth. For best results apply to grasses moist from dew, rain or sprinkling. Rain or sprinkling within 24 hours after application reduces weed control effectiveness. NOTE: Not for use at time of seeding or on seedling grasses. Wait at least until after its fourth mowing. Delay planting grass seed for at least a month after use. ✓
