

BACK RUBBING DEVICES FOR BEEF CATTLE ONLY: For the reduction of Horn Flies and lice dilute 2 gallons with $9\frac{1}{2}$ gallons Diesel fuel or furnace type oil. DO NOT use any other type of oil. Use one gallon of solution to saturate burlap on "back rubber", soak burlap every 2 to 3 weeks. DO NOT MAKE ACCESSIBLE TO DAIRY ANIMALS.
