Dear Ms. Brown:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the following comments.

Topic	Action required
Directions for Use	In the section labeled "To control carpet beetles and clothes moths" revise the first sentence so that it reads: "Spray edges of carpeting and spot treat under carpeting, rugs, and in closets."
Precautionary Statements - Hazards to Humans & Domestic Animals	Remove the following two sentences since they belong with the first aid statements (and are already covered there): "If swallowed, do not induce vomiting. Call a physician immediately."

Topic	Action required
First Aid	Replace current "If swallowed" text with the following text:  "IF SWALLOWED: Call a physician or poison control center immediately. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol."

Submit three (3) copies of your final printed labeling incorporating the above changes prior to releasing your product for shipment. If the above provisions are not complied with the registration will be subject to cancellation in accordance with FIFRA Section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A copy of your label stamped "accepted with comments" is enclosed for your records.

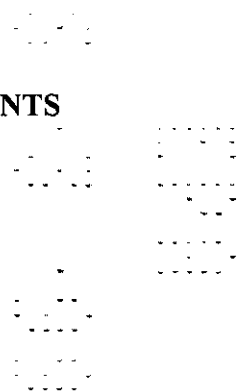

## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

### 1. WHAT IS THIS PRODUCT FOR?

This easy to use product will kill Spiders in and around the home: in dark corners of rooms, door and window sills, garages, closets and other tested areas. ferti-lome® Spider Spray can also be used to eliminate and control Cockroaches, Ants, Silverfish, Fleas, Crickets, Clothes Moths, Flies, Gnats, Mosquitoes, Small Flying Moths, Scorpions, Brown Dog Ticks, Carpet Beetles, Cigarette Beetles and Centipedes.

### 2. HOW DO YOU USE IT?

Application of this product in indoor residential settings, other than as a spot and/or crack and crevice treatment is not permitted.

**TO CONTROL SPIDERS AND OTHER PESTS:** Shake before using. Spray infested surfaces until wet. Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Spiders and other pests flushed out of hiding should be sprayed directly.

**TO CONTROL CARPET BEETLES AND CLOTHES MOTHS:** Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets and infested area of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

**TO CONTROL GNATS, HOUSE FLIES, MOSQUITOES, SMALL FLYING MOTHS:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages and other places where these insects alight or congregate.

**TO CONTROL FLEAS AND TICKS INDOORS:** Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. **DO NOT TREAT PETS WITH THIS PRODUCT.** To control the source of the infestations, pets inhabiting premises should be treated with a product registered for application to animals.

When used as directed, this product will kill annoying Spiders and therefore tend to eliminate unsightly spider webs. This specially formulated product will also kill Cockroaches, Ants, Silverfish, Fleas, Crickets, Clothes Moths, Flies, Gnats, Mosquitoes, Small Flying Moths, Scorpions, Brown Dog Ticks, Carpet Beetles, Cigarette Beetles and Centipedes in and around the home.

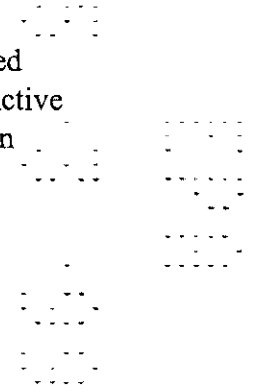

- IF IN EYES** - Flush eyes for at least 15 minutes with water. Call a physician immediately.
