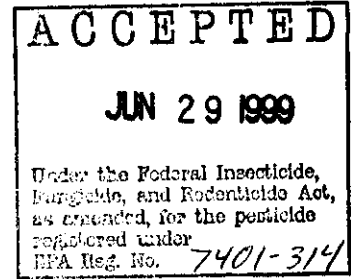

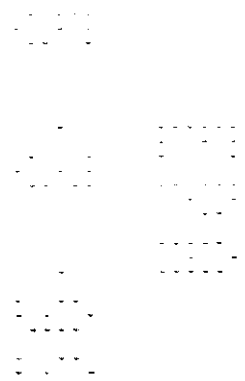

### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### 1. WHAT IS THIS PACKAGE FOR?

Use this product to kill Fleas and Ticks that exist in and around the home and yard. ferti-lome® Flea & Tick Spray is ideal for treating infested pet sleeping areas, localized areas of floor and floor covering, closets and along and behind windows, door frames and baseboards.

#### 2. HOW DO YOU USE IT?

Application of this product in indoor residential settings, other than as a spot and/or crack and crevice treatment is not permitted.

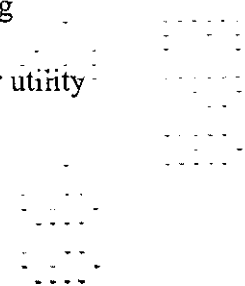
TO CONTROL FLEAS INDOORS: Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. DO NOT TREAT PETS WITH THIS PRODUCT. To control the source of flea infestations, pets inhabiting premises should be treated with a product registered for application to animals.

TO CONTROL TICKS: Thoroughly spray sleeping quarters of animal. Spray infested areas around baseboards, window and door frames, wall and floor coverings where localized areas of infestation occur. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH THIS PRODUCT.

FOR OUTDOOR USE: As an aid in reducing annoyance from fleas and ticks. Spray outside surfaces of screens, doors, windows, frames or wherever these pests may enter the home. Also treat surfaces around porches, in garages, around the yard and other places where these pests may congregate.

OTHER INSECTS: To kill Cockroaches, Ants, Silverfish, Spiders, Clothes Moths, Flies, Gnats, Mosquitoes, Carpet Beetles and Scorpions: Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, under carpeting and floor coverings, behind and beneath sinks, stoves, refrigerators, cabinets and garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be spray directly.

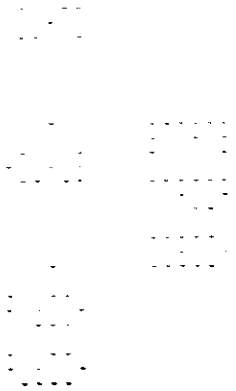

**STATEMENT OF PRACTICAL TREATMENT**

- IF SWALLOWED** - Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.
- IF INHALED** - Remove victim to fresh air. Apply respiration if indicated.
- IF ON SKIN** - Remove contaminated clothing and wash affected areas with soap and water.
- IF IN EYES** - Flush eyes for at least 15 minutes with water. Call a physician immediately.
