INDOOR USE:

ANTS, ROACHES, SPIDERS, CRICKETS, SILVERFISH, SCOR-PIONS-AND WATER BUGS: Spray into cracks, crevices, and baseboards, and other places where insects hide. Apply behind and underneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. For ants, spray trails and places where ants enter premises. Repeat as needed.

#### OUTDOOR USE:

ANTS, CLOVERMITES, CRICKETS, EARWIGS, FLEAS, FLIES, MILLIPEDES, MOSQUITOES, SOWBUGS, AND BROWN DOG TICKS: Spray infested sreas thoroughly, outside surfaces of screens, doors, window frames, foundations, patios and other places where insects may enter. For ents, spray hills and runways. Repeat as necessary.

No not apply to rugs, carpets, draperies, wallpaper, or similar material that may be stained or watermarked. The solvents of 'his formulation may stain certain plastic, rubber, and asphalt material, such as tiles and floor coverings. Do not treat such inaterial without first testing a small inconspicuous area, Do not use as a space spray. Provide adequate ventilation of

area being treated. Do not apply to animals or humans. Do not use on food crops.

Do not spray foodstuffs or plants. Remove pets and cover fish bow's before spraying. Do not allow children to contact troated areas until surfaces are dry.
