**DIRECTIONS FOR USE**  
 It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Hi-Yield Household Insect Spray Concentrate is a highly effective formulation which provides rapid kill of crawling insects listed. In addition to rapid kill, this product provides good residual killing action.

Hi-Yield Household Insect Spray Concentrate must be diluted with water before use. Mix at the rate of 8 fluid ounces to 1 gallon of water (2 ounces to 1 quart of water). Do not use higher than this recommended rate.

**INDOOR USE:**  
**ANTS, ROACHES, SPIDERS, CRICKETS, SILVERFISH, SCORPIONS AND WATER BUGS:** Spray into cracks, crevices, and baseboards, and other places where insects hide. Apply behind and underneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. For ants, spray trails and places where ants enter premises. Repeat as needed.

**OUTDOOR USE:**  
**ANTS, CLOVERMITES, CRICKETS, EARWIGS, FLEAS, FLIES, MILLIPEDES, MOSQUITOES, SOWBUGS, AND BROWN DOG TICKS:** Spray infested areas thoroughly, outside surfaces of screens, doors, window frames, foundations, patios and other places where insects may enter. For ants, spray hills and runways. Repeat as necessary.

Do not apply to rugs, carpets, draperies, wallpaper, or similar material that may be stained or watermarked. The solvents of this formulation may stain certain plastic, rubber, and asphalt material, such as tiles and floor coverings. Do not treat such material without first testing a small inconspicuous area. Do not use as a space spray. Provide adequate ventilation of area being treated. Do not apply to animals or humans. Do not use on food crops. Do not spray foodstuffs or plants. Remove pets and cover fish bowls before spraying. Do not allow children to contact treated areas until surfaces are dry.
