

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & DOMESTIC ANIMALS

CAUTION: May be harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling and before eating or smoking. STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED—Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Never give anything by mouth to an unconscious person.

IF INHALED—Remove victim to fresh air. Apply artificial respiration if indicated.

IF ON SKIN—Remove contaminated clothing and wash affected areas with soap and water.

IF IN EYES—Flush eyes with plenty of water. Get medical attention if irritation persists.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is antidotal. Give by injection only.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Hi-Yield DURSBAN* GARDEN DUST is a new, easy to use product for effectively killing destructive insects on flowers, shrubs, vegetables and around buildings.

FLOWERS, SHRUBS, TREES, VINES & EVERGREENS: To control Aphids, Bagworms, Cutworms, Grasshoppers, Tent Caterpillars, Fall Webworms, Mealybugs, Mites, Spittlebugs, Thrips, Whiteflies, Orangestriped Oakworm and Yellow-necked Caterpillar. Uniformly dust upper and lower leaf surfaces and infested limb areas. Treat when pest appear and repeat at 7-10 day intervals, if needed.

VEGETABLES: SWEET CORN, POPCORN & FIELD CORN: To control Armyworms, Billbugs, Corn rootworms, Cutworms, Grasshoppers, Lesser cornstalk borer and Wireworms. For Corn rootworms, Cutworms, and Wireworm treatment, uniformly apply 1 lb. of dust per 300 sq. ft. of soil surface.

BROCCOLI, BRUSSELS SPROUTS, CABBAGE, CAULIFLOWER, RADISHES & RUTABAGAS: To control Root Maggots. Uniformly apply 1 1/4 lbs. dust per 300 feet of row at planting time. Thoroughly work dust into top layer of soil. For transplanted crops, apply 1 1/4 lbs. per 300 feet of row to the soil at the base of the plant. For radishes and rutabagas do not make more than one application per season. Do not use rutabaga tops for food or feed purposes.

SWEET POTATOES: To control Flea beetles & Wireworms. Uniformly apply 1 1/4 lbs. per 300 sq. ft. of soil surface before planting. Work dust into soil to a depth of 4 to 6 inches. Plant as soon as possible after treatment. Do not make more than one application per season.

OUTSIDE BUILDINGS: To help prevent infestation of buildings by ants, crickets, earwigs, millipedes, fleas, Brown dog ticks and sowbugs (pillbugs), treat a band of soil 6 to 10 feet wide around and adjacent to buildings, where pests are active and may find entrance. Uniformly apply at a rate of 1 lb. per 200 sq. ft. After application, lightly water the treated band.

DISPOSAL.

Do not reuse empty container. Wrap container and put in trash collection.
